The TJM HIGH COUNTRY – SURF TO SNOW

WHAT IS MY INVESTMENT, WHAT DO I NEED TO DO, HOW DO I DO IT?

- **\$500 car entry fee (non refundable)** will secure your vehicle's entry. Once the \$500 car entry is paid you will receive the Just4Kids Starter's Pack, which includes 2 promotional Just4Kids T shirts, 2 car door decals, receipt book, TJM vehicle booklets, and a J4K collection tin to assist you with your donation component, along with other useful hints and items to get you started on the J4K motor trail event.
- **Investment.** After the \$500 car entry is paid, you will receive an invoice for your per person entry fee of \$2,200 (download entry form at www.just4kidsmotortrail.com.au). This investment of \$2,200 includes your costs for National Park fees, itinerary tours, meals and all functions, including the Meet and Greet Outback Spectacular on the Gold Coast.
- Your **Charitable donation component** included in the \$2,200 per person entry, is \$1000.00 (the tax deductible donation component) and is required per each adult, (adult is 17 yrs and over) travelling in the entered vehicle.
Please note – sponsor donated funds deposited into the Just4Kids account to support your team entry are NOT refundable, by law, if you cancel your entry at any time. Please be aware that you cannot issue a Just4Kids tax receipt to your sponsor unless the funds are banked into the Just4Kids account.
- **Accommodation** will be varied for the TJM High Country event. Just4Kids will reserve rooms and camp sites that will be payable by each individual entrant. You will need to confirm your booking direct with the provider from the J4K accommodation list supplied at the time of registration.
- **Meals.** Your three quality breakfast, lunch and evening meals investment is included in your \$2,200 per adult cost for the 10 days. It also includes the Meet and Greet function at Outback Spectacular and the grand final night dinner (drinks not included) and presentation on the last night of the TJM High Country event at Thredbo Village.
- **Additional Meal investment summary**, for children travelling in your vehicle, including events & functions.

Children – 1-4 years – \$200 per child
5-11 years - \$500 per child (if travelling with family)
12-15 years - \$700 per child (if travelling with family)
16 years and over – \$1,100 per person Adult value.

- **Excursions.** Your entry will cover any J4K organised tours as per the itinerary. For any optional tours a list will be made available to assist you with lay day choices – these are payable by the individual entrant direct.
- **Team expenses** - Fuel, as well as vehicle expenses, are payable by individual entrant.
- **What is the tax-deductible donation used for**

These moneys are used to support the disabled, sick and disadvantaged children or their respective organisations along the Just4Kids Motor Trail. We also make donations to the various schools we visit to help with any special projects they may be involved with. Additional funds are distributed throughout the year to Just4Kids projects and through the Just4Kids Youth Support Program

Auction Items. Each vehicle is requested to bring at least one quality item for auctioning at local functions. Please contact us for more information on this if required.

Can my entry and other associated costs be sponsored by an organisation?

Yes, you can obtain sponsorship for your entry and costs if you wish. The majority of entrants do. The minimum requirement of \$1000 donation per person is 100% tax deductible. Details about Just4Kids and their charity status and registration forms are available on the website. We gratefully accept additional funds raised for our youth support programme.

Do I need a four wheel drive or an all wheel drive?

Can I hire an off road unit that complies with J4K requirements – Yes, you can

The route is suitable for 4x4 and A.W.D. vehicles and well set up two wheel drive vehicles. The 2016 circuit is also suitable for camper trailers, roof top tents, tray back campers and low profile RV Campers. We can also offer you our contacts for packaged 4x4 hire units set up for our event which can include a roof top tent and all camping items if you intend to camp. Other units are also available if you intend to use on site accommodation but prefer good off road capability. Please contact us for discounts through our preferred suppliers.

There is a requirements check list available for you and your vehicle once you register.

If you have any concerns please check with the Motor Trail Director, Mark Louez well in advance about the circuit and expected conditions Ph: 0429 090 199.

Keep in mind that road conditions may vary from the official survey date.

Can entrants dress in a theme, as well as decorate their vehicle?

Yes, as we will be visiting schools and large groups of children, a theme for your entry is encouraged and fun POINTS are awarded for the most innovative themes. If you have children it is also a great way for them to enjoy the trip and make good friends with other young persons.

Do I have to provide my own meals and arrange accommodation along the way?

No, this is organised by the volunteer committee and all meals are part of your entry costs (please see above).

If you have special dietary needs arrangements will be put in place to manage your

requirements. You will receive a form for this on registration which must be filled out and all personal information is held in a sealed envelope by our medic.

All you will need to do is just relax, have fun and enjoy the day in the country. Your reserved accommodation will be pre organised and a list sent to you upon receipt of your entry form and \$500 car entry. It is up to the individual entrants to book and pay for their own accommodation using this list that contains cost effective options for accommodation.

Camping Trailers

This event is very suitable for off road 4x4 camper trailers if you wish to reduce your accommodation cost. You will also need to carry a range of trailer spares, see TJM compulsory listing of items. Most areas we are visiting will have camping grounds and/or caravan parks.

Will there be mobile phone coverage in the towns we are visiting?

Most of the areas we travel through on this event will have Telstra coverage.

In car and dash mount navigation units will also work for the entire Surf to Snow circuit.

A list of all overnight stops, with the address and phone number of the Motels and Caravan/Camping Parks will be provided following receipt of your entry fee.

Contact OV1 or OV 2 if you need to make an emergency call from a remote area by using the J4K Satellite phones, .

Is there support if my vehicle breaks down?

Yes, we offer assistance if you break down. If the issue cannot be fully resolved we will ensure you get to the next serviceable area where more comprehensive work can be carried out.

It is advisable on any J4K motor trail event to upgrade your RACQ membership to Gold for that year so you have all of the services that RACQ can offer. RACQ does support most areas as long as you are a member. They are also linked with NRMA for the NSW areas.

Driving to the conditions of the road with lower speeds and good tyres with a vehicle that is not overloaded makes for a trouble free event. Please read the J4K/TJM suggested and compulsory items.

Can Just4Kids assist me with my fundraising?

Just4Kids has a variety of concepts to help you raise funds.

When do I have to get my entry registration and associated payments in by?

An expression of interest is desirable ASAP as numbers will be limited. We suggest you pay the \$500 car entry to secure your team position and finalise your total payment one month prior to the commencement of the event.

The \$500 car entry is non refundable. You can pay your \$2,200 in instalments but all monies must be received 1 month prior to the event.

Refund Policy – 50% refund up to 1 month prior to event. No refunds 4 weeks prior or during the event.

Can I make split Payments?

YES. Just4Kids can bill you Monthly or you can pay via Credit Card. There is a 1% charge for choosing the credit card facility.

The car entry fee of \$500 is required to reserve your place and your preferred team/vehicle number. On payment of your team/car entry we will issue you the with the Just4Kids pre arranged accommodation list. You will then be issued with an invoice for the event based on \$2,200 per adult person in your vehicle plus the children's meal rate. The per person entry **donation component only**, being \$1000 per adult, is 100% claimable as a Charitable donation. For more information about tax claims we suggest you contact your accountant as we are not an advisory on tax issues.

How many other cars will be participating in Just4Kids TJM Surf to Snow event?

The 2016 Just4Kids Motor Trail is set at around 25 units.
