



Just4Kids Youth Support Program – Guidelines

Pacific Rim Just for Kids Inc. (Just4Kids) is a Queensland based registered charity focusing on assisting disabled and disadvantaged children.

Just4Kids is seeking to formally support several projects to provide a better quality of life for youth in need. Projects can range from support of individual youth with Special needs to partnership alliances with other Foundations, Charities or Community Organisations who undertake essential work in the community.

Priority Areas

The Just4Kids committee has identified several priority areas for the development of alliance partnerships, including:

- Working with groups to support disabled and disadvantaged youth access needed services in regional and remote locations.
- Working with groups to assist in the provision of active recreation and social opportunities to youth-in-need.
- Working with groups to assist youth suffering from Autism, learning disorders or Osteosarcoma.
- Working with groups who support the carers and families of disabled or disadvantaged youth.

Please note that priority areas will be reviewed regularly by the Just4Kids committee and are subject to change.

Funding Levels

Just4Kids is a small, community-based charity and, as such, has a far greater demand for its support than can be provided. Just4Kids targets relatively small projects and alliance partnerships with community groups to assist the broadest possible range of youth in need. Funding levels are assessed on a case-by-case basis. However, priority will be given to projects and groups where the partnership's focus with Just4Kids is more holistic, for example, support of fundraising activities and events and/or promotional support, rather than purely a funding request. We strongly recommend that you contact Just4Kids at info@just4kidsmotortrail.com.au to discuss your project if you seek direct funding as a significant part of your support request. Any funding amount provided through this process will be provided exclusive of GST.

Limits for equipment

Just4Kids funding for equipment is limited to the provision of small scale, personalised equipment for youth in need that is directly related to their condition and vital to the child's quality of life. Unfortunately, at this time, funding for larger capital items cannot be accommodated.

Application Assessment Process

Applications under this program are assessed uniformly.

Individuals and Organisations will receive an acknowledgement e-mail to their nominated e-mail address within one week of receipt of the application by the Charity. If you have not received this confirmation within seven days, don't hesitate to contact the Charity to ensure your project has been received.

Charity staff will ensure the application meets the program's eligibility criteria and that all required information has been provided.

All completed applications that meet the eligibility requirements will then be forwarded to our Grants Committee for assessment. As we receive far more requests than we can support, this process is very competitive, and unfortunately, not all projects can be supported. You mustn't make commitments based on your application until the assessment result is confirmed.

It is envisaged that this process will take approximately four weeks, at which time all applicants will be notified in writing of the outcome of their application.

As part of the assessment process, the Grants Committee may seek additional information or undertake independent checks on part or all the information provided in the application form. Should further information be required, the contact person nominated on the form in section 1.5 of the application will be contacted in the first instance. By signing the application form, you agree to allow Just4Kids the right to undertake independent checks on any aspect of the proposal that the Committee sees fit.

Successful applicants will also be listed on the Just4Kids website and in relevant promotional materials.

Additional Support Avenues

As noted, Just4Kids cannot support each worthwhile project for which our support is being sought. From time to time, however, our alliance partner organisations may be able to assist in supporting applications that fall outside our ability to approve. If you are willing to allow Just4Kids to discuss your proposal with our partner groups should such an opportunity arise during the assessment process, please check the box in Section 5.1 of the application form?

Applications for which alternative support avenues are to be explored will require additional time, and the outcome of the application may take longer than the approximate four week turnaround time noted above.

Should an application be supported via a Just4Kids partner group, an acknowledgement of the support provided by the partner organisation may be required.

Signing the form

Please note that a person with authority must sign the form to enter into an agreement with the Charity in relation to the project on behalf of the individual/group seeking support, should your application be successful.

Submission of the Form

Please note that applications are assessed monthly but can be submitted at any time. You should allow a minimum of two months from the date of submission to when support from the Charity is first required.

No attachments are required at this time. Should the Charity require further information and/or attachments, we will contact you in due course.

Please keep your application as concise as possible but remember to answer all the questions to the best of your ability. Should we require further information as part of the assessment process, we will contact you.

Only one copy of the application should be provided (if applying by mail, please do not bind or staple the document).

Applications can be submitted by mail or e-mail (with an electronic signature or a PDF scan of the original document). Faxed applications cannot be accepted at this time.
